The Carlton Fire Co. gave an update on calls and man hours.

Legislator Fitzak stated that there are ongoing discussions about the Parkway.

A motion by Mr. McCue to approve the November Vouchers, Second by Mrs. Yockel and carried

Under Old Business Mr. Gifaldi, ZEO stated that Mr. Wells of Hanlon Rd has moved all tractor trailer trucks having to do with his trucking business off of Hanlon Rd. Mr. Gifaldi will continue to work with Mr. Wells to have the Property cleaned up.

Mr. Gifaldi also stated that he is still working with residents in Sunset regarding Chickens.

A motion was made by Mr. Woolston to reappoint George Miller to the Board of Assessment Review term 10/1/2022- 9/30/2027. Motion seconded by Mr. McCue and carried.

Mercy Flight out of Batavia gave a statement regarding Emergency services they would like to provide the Town of Carlton.

Monroe Ambulance Gave a full proposal to the Town Board requesting The Town of Carlton to choose the company to provide the Town emergency services. Discussion followed.

Eileen Wuethrich of Brighton Cliff requested information on where the Ambulances would be stationed and process of 911 calls to dispatch. Discussion followed

Discussions followed between the Town Board, Monroe Ambulance and Town residents.

Legislator Fitzak Stated that the Towns and Orleans County has been working diligently for over a year to try to come up with a solution for COVA and the emergency services. There have been monthly meetings and hours upon hours of work put into this issue.

A motion by Mr. Woolston to approve a One year contract with Monroe Ambulance to provide the Town of Carlton with emergency services
